- New Items for discussion, no motions will be made.
 - Chicken Ordinance Alisha has had people ask about having chickens in town. Not looking to vote at this time but would like the board to research such things as what other towns currently have in place. Would want to ask what community thinks of the idea. If we were to move forward, it's suggested people would apply for a permit, they would need to show their plans, limit on number of chickens, have fences.
 - Solar Ordinance We need to have defined ordinances in place stating what is allowed and not allowed, property lines, types of mounts, etc.
 - Yard Waste Collection An idea came about to have yard waste collections maybe every other week. Will limit access to the sewer pond. Would need to be burnable yard waste that fits in bags.
 - Golf stickers Stickers were started in 8/2019. They expire in 2023 but question is whether it's the beginning or end. Agreed to not renew in spring. New stickers will need to be a different color.
